

*You are invited* to a regional workshop designed to demonstrate the principles of “conservation zoning” and “conservation subdivision,” an approach we’re calling *Growing Greener: Conservation By Design*.

### What is *Growing Greener*?

*Growing Greener* is a statewide community planning initiative, a collaborative effort of the Pennsylvania Department of Conservation and Natural Resources, the Governor’s Center for Local Government Services, Natural Lands Trust, and an advisory committee comprised of officials from state and local agencies, non-profits and the private sector. *Growing Greener* is designed to help communities use the development regulation process to their advantage to protect interconnected networks of greenways and permanent open space. The program offers multi-media educational material and technical assistance to communities so that conservation and development objectives may be achieved simultaneously, in a manner that is fair to all parties concerned.

**Communities can take control of their destinies so that their conservation goals are achieved in a manner fair to all parties concerned. All that is needed are some relatively straight-forward amendments to municipal comprehensive plans, zoning ordinances, and subdivision ordinances.**

**If you would prefer to see new development create more livable communities in the process, the *Growing Greener* approach might be right for you.**
